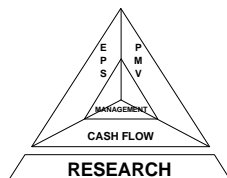

The source of the distribution is net investment income, capital gains, and return of capital. Based on current earnings on a book basis, approximately \$0.011 per share is from net investment income, \$0.020 per share is from capital gains and \$0.039 per share is a return of capital. The final determination of the proportion of capital gains, ordinary income, and non-taxable return of capital, if any, distributed in 2007 will be made after year end. All shareholders will receive written notification regarding the components and tax treatment for all 2007 distributions in early 2008 via Form 1099-DIV.
