The source of the distribution is net investment income, capital gains, and a return of capital. Based on current earnings on a book basis, approximately \$0.013 per share is from net investment income, \$0.033 per share is from net realized capital gains, and \$0.054 per share is a return of capital. This estimate is based on book basis earnings as of record date.

The final determination of the proportion of capital gains, ordinary income, and non-taxable return of capital, if any, distributed in 2014 will be made after year end. All taxable shareholders will receive written notification regarding the components and tax treatment for all 2014 distributions in early 2015 via Form 1099-DIV.
