The source of the distribution is net investment income and return of capital. Based on current earnings on a book basis, approximately \$0.008 per share is from net investment income and \$0.062 is a return of capital. This estimate is based on book basis earnings as of the record date.

The final determination of the proportion of capital gains, ordinary income, and non-taxable return of capital, if any, distributed in 2018 will be made after year end. All taxable shareholders will receive written notification regarding the components and tax treatment for all 2018 distributions in early 2019 via Form 1099-DIV.
